




Fig.1 Power Dissipation Derating Curve






Fig.2 Drain Current Derating Curve


Fig.4 Typical Output Characteristics(II)










### Fig.5 Breakdown Voltage vs. Junction Temperature

## Fig.8 Forward Transfer Admittance vs. Drain Current







Fig.10 Static Drain - Source On - State





Fig.13 Static Drain - Source On - State Resistance vs. Drain Current (III)




Fig.17 Typical Capacitance vs.

### Fig.18 Switching Characteristics






Fig.19 Source Current vs. Source Drain Voltage


